3 FINAL MUNICIPAL SERVICE REVIEW (MSR) AND SPHERE OF INFLUENCE (SOI) FOR LOWER JONES TRACT AND UPPER JONES TRACT RECLAMATION DISTRICTS

(LAFC 17-17)

(Action by Regular Members)

The Commission will review and discuss the Final MSR and SOI report for Reclamation District 2038 – Lower Jones Tract and Reclamation District 2039 - Upper Jones Tract.

James Glaser, Executive Officer, provided an overview of the process to prepare the Municipal Service Review (MSR) and the Sphere of Influence (SOI). He stated that LAFCo is required to prepare an MSR for each of its incorporated cities and special districts and update the SOI's.

RD 2038 and RD 2039 have indicated to LAFCo that they would like to consolidate. A MSR and an Updated SOI is needed before a consolidation can be accomplished. LAFCo Staff recommended that the Commission approve the Final Municipal Service Review and Sphere of Influence Update for Upper and Lower Jones Tract Reclamation Districts.

Mr. Glaser informed the Commission that on their dais is a letter from Mr. Martin Harris, Terra Land Group opposing this Final MSR/SOI.

Chairman Patti opened the floor to Commissioner Comments.

No Comments were made.

The motion passed by a unanimous vote of the voting members of the Commission.

RECRUITMENT FOR A PUBLIC MEMBER COMMISSIONER
 (Action by All Members)
 Request to the Commission to initiate the recruitment process for a Public Member to serve on the Commission

Mr. James Glaser, Executive Officer, stated that according to the Commission policy for regular and alternate public members, a public member can serve for a term of four years and a person may serve no more than two four-year terms as either a Public or an Alternate Public Member. The partial two-year term for Alternate Public Member Charles Manne expired in May 2018.

The procedure to initiate recruitment of an Alternate Public Member is for the Commission to direct the Executive Officer to announce that applications would be accepted. Availability of the Alternate Public Member seat would be announced by posting and mailing a notice to all local agencies, as well as placing a notice on the LAFCo website. If directed by the Commission, the Executive Officer will also issue a press release. The results of the recruitment effort will be placed on the Commission agenda and final appointment to fill a vacancy may not be made for 21 days after posting notice

Chairman Patti opened the floor to Commissioner Comments.

Commissioner Andrade asked how does LAFCo announce the Alternate Public Member opening.

James Glaser, Executive Officer, stated that a press release will be sent to the newspapers and to the city clerks. The Public Member and Alternate Public Member can not be an elected official. Once LAFCo receives resumes and applications a date will be set for the applicants to be interviewed at a Commission Meeting. An applicant may be appointed at that time.

5. SAN JOAQUIN UNINCORPORATED ISLANDS REPORT

(Action by Regular Members)

The Commission will discuss the existence of unincorporated land within the cities.

Mr. James Glaser, Executive Office, presented an overview of the unincorporated islands within San Joaquin County.

At the request of Commission, this report was prepared to provide the Commission with a preliminary assessment of the existing unincorporated islands and to provide a guideline on what steps/actions are needed if the Commission desires to address this issue further.

The County has 32 unincorporated islands comprising of 4,777 acres. The City of Stockton has 16 islands, Tracy-5; Manteca-5; Lathrop-2; Lodi-3; Ripon-1 island and Escalon-0 islands. Approximately 21,866 residents reside in these county pockets that receive limited municipal services. Staff reviewed past annexation files to see why cities have grown around certain county pockets and that most often county residents resisted annexation because of their perception of stricter oversight over their properties by the annexing city, fear of additional taxes or fees, and the desire to maintain their community identity. For cities, there was little incentive to annex due to infrastructure deficiencies and service costs, low sales tax base, and there was not a priority for cities to annex these areas.

Special legislation was enacted in 2001 to facilitate annexation of unincorporated islands for islands 75 acres or less without voter protest or election. In 2005, the law increased the size of the islands to 150 acres.

According to Government Code §56375.3 an "island" that requires LAFCo approval and waiver of protest of proceedings must meet all of the following:

- Annexation is proposed by the city
- 150 acres or less in size
- Surrounded or substantially surrounded by the annexing city
- Not a gated community
- Substantially developed or developing based on the availability of public utilities, presence of public improvements or the presence of physical improvements
- · Not prime agricultural land
- Receiving benefits from the annexing city or will benefit from the city
- Not created after January 1, 2014
- Within the annexing city's sphere of influence

The Commission does not have the power to initiate annexations. The control for the annexation of unincorporated islands lies with the city. The Commission, however, has the power to form and adopt policies to encourage cities to annex their unincorporated islands. In 2007, the Commission adopted annexation policies intended to discourage the creation of islands and required cities to show they have made reasonable efforts to include an unincorporated island in a pending annexation application.

Suggested steps for developing an island annexation program:

- Workshop (Commission and Staff)
 - a. Discussion of Staff Report
 - b. Determination of Commissioner's Role
 - c. Gather additional information as needed
- 2. Meeting with LAFCo and City and County Representatives
 - a. Identify stakeholder interest
 - b. Identify obstacles to island annexations
- 3. Development of Island Annexation Polices
 - a. Ad Hoc Committee
 - b. Public Hearing

Chairman Patti opened the floor to Commissioner Comments.

Commissioner Johnson thanked the staff for the thorough report, and that he liked the strategy of sending the report out to the cities to get their feedback on annexing the islands. Commissioner Johnson also agrees that the Commission needs to collaborate with the cities.

Commissioner Kuehne sees the report as a way to force cities hand on facing this issue and likes how the staff will help the cities get to the goal of annexing the islands. Commissioner Kuehne believes LAFCo should start with the islands that are 150 acres and less.

Commissioner Andrade stated that this has been an issue for a long time. There needs to be a discussion on why the islands were created to begin with and why there has been no movement to annexing the islands. The workshop session is a welcome idea and it is important to let all the cities know what LAFCo is looking at doing. Commissioner Andrade wanted to know if this will include areas such as Morada or strictly unincorporated islands.

Mr. Glaser, Executive Officer, replied that this is only for unincorporated islands.

Commissioner Winn appreciates the thoughts on this problem. He stated that he has worked in other counties and has had similar problems with residents regarding jurisdiction of county and city services. It will be challenging to get county residents to agree to be annexed into cities when they have septic systems and water and are adamant on not paying connection fees. There are also county residents that are very protective of their community and he feels that annexation of islands should be done on a case by case

basis. Commissioner Winn agrees that the Commission should move forward in this discussion.

Chairman Patti opened the floor to Public Comments.

Gene Neely, Chief, Lathrop – Manteca Fire Protection District, spoke against unincorporated islands.

Bob Bentz spoke against annexation of incorporated islands.

Chairman Patti closed Public Comments

Chairman Patti gave direction to move forward with distributing this report to the cities.

Draft Municipal Service Review/Interim Sphere of Influence Plan

Workshop City of Stockton

Recommendation

It is recommended that after receiving testimony and providing comments on the Draft Municipal Service Review/Interim Sphere of Influence Plan for the City of Stockton that the matter be scheduled for a public hearing on February 14, 2019. It is also recommended that the City of Stockton be directed to include the unincorporated islands within the 10-year planning horizon.

Background

A Municipal Service Review (MSR) is a comprehensive review of an agency intended to obtain information about the agency's ability to provide services. Its purpose is to evaluate the provision of services from a comprehensive perspective and recommend actions, when necessary, to promote the efficient provision of those services. Service reviews are intended to serve as a tool to help LAFCo, the public and other agencies better understand the public service structure and evaluate options for the provision of efficient and effective public services that the agency currently provides. State law requires that LAFCo update Spheres of Influence and prepare a Municipal Service Review in conjunction with that update.

The MSR is required by the Cortese-Knox-Hertzberg Act to have six categories, as defined by the San Joaquin LAFCo "Service Review Policies" December 14, 2012. Each of these categories requires a written determination. The six categories are as follows:

Growth and Population Projections for the Affected Area

- The Location and Characteristics of any Disadvantage Unincorporated Communities within or Contiguous to the Sphere of Influence
- Present and Planned Capacity of Public Facilities and Adequacy of Public Services, Including Infrastructure Needs and Deficiencies
- Financial Ability of Agencies to Provide Services
- Status of and Opportunities for Shared Facilities
- Accountability for Community Service Needs, Including Governmental Structure and Operational Efficiencies

In determining a sphere of influence, the Commission is required to consider and make written determinations with respect to the following factors (Government Code Section 56425):

- The Present and Planned Land Uses in the Area, Including Agricultural and Open Space Lands.
- The Present and Probable Need for Public Facilities and Services in the Area.
- The Present Capacity of Public Facilities and Adequacy of Public Services that the Agency Provides or is Authorized to Provide.
- The Existence of Any Social or Economic Communities of Interest in the Area if the Commission Determines that they are Relevant to the Agency.
- The Present and Probable Need for those Public Facilities and Services within any Disadvantaged Unincorporated Communities (DUCs) within the Sphere of Influence.

The sphere of influence for the City of Stockton was last updated in 2008 and was approved by the Commission for a 10-year planning period. The City has just completed the process of updating its General Plan (Envision Stockton 2040 General Plan Update). As a result, the City intends to submit another application for the Municipal Service Review and Sphere of Influence (SOI) Plan to reflect the newly adopted General Plan. The proposal before the Commission represents an "interim" SOI and is consistent with the City's 2035 General Plan (2007). This interim SOI is necessary as the City has several pending annexation applications.

Figure 2-10 identifies the areas proposed for the 10-year planning horizon. The area shown is significantly less in scale than the 10-year plan previously approved by the Commission. These areas indicate where annexations could occur in the short-term or "interim basis". A new Sphere of Influence Plan will be subsequently submitted consistent with the newly adopted General Plan.

The report states on page 2-28 that the "City is committed to continue to work with San Joaquin County and property owners to annex existing unincorporated islands within the current city limits". However, the 10-year plan does not show these islands. It is recommended that Figure 2-10 be amended to include these islands so that there would not be a hindrance should progress occur on the inclusion of some or all of these islands into the City.

The implication of SB-5, regarding 200-year flood protection is also addressed. A number of local agencies, including several reclamation districts, are working with the U.S. Army Corps of Engineers on the Lower San Joaquin River Feasibility Study. The study is a multi-year \$10 million study that will help determine improvements needed to reach or exceed the 200-year level of flood protection. The Lower San Joaquin Feasibility Study will reach the part of San Joaquin County along the San Joaquin River up to and through Stockton including the Lodi Waste Water Treatment Plant. In addition, the study includes the watersheds east of Stockton and covers nearly 140 miles of levees. Some of the developments proposed in Stockton will provide their own level of flood protection.

The document has been transmitted to the surrounding jurisdictions and fire protection districts. LAFCo has not yet received any comments. Any comments will be included in the final report.

The Commission's service review policy sets forth the procedure for public participation and public hearing. The policy requires a two-step process for the adoption of a service review: 1) a public meeting/workshop with the Commission to accept comments from the public and the Commission "prior to finalizing the document", and 2) a formal 21-day review period and public hearing. Staff will provide public notice for the February 14, 2019 meeting to meet our legal obligation for a public hearing. The Commission will be able to adopt the MSR at that meeting or may continue the matter to a future meeting. A motion is attached for Commission's consideration.

The draft report was previously transmitted at the December 13, 2019 meeting to the Commissioners for their early review.
